Request for the submission of proposals Dumfries Landfill Rehabilitation Project

Grenada Solid Waste Management Authority is currently in the process of commencing civil works at Dumfries landfill in Carriacou involving rehabilitation of the currently operational landfill. This project is to be financed by the Grenada Solid Waste Management Authority and has a duration of two (2) to three (3) months.

To carry out such work, the GSWMA is inviting the submission of proposals from interested parties for the provision of equipment and services for the following:

1. Excavator on rental/lease.

Required for excavation of earth, moving and compacting garbage to create berms based on design specifications provided by the GSWMA. The perspective supplier shall provide:

- (a) Details of the make, model and age of the excavator.
- (b) Weekly and monthly rental rates for the excavator operated by the company staff. and
- (c) Weekly and monthly rental rates for the excavator operated by a licensed and experienced GSWMA heavy equipment operator.

2. Front end Loader or Backhoe services.

Required for loading earth material, including aggregates onto trucks. The perspective supplier shall provide: (a) Details of the type, make, model and age of the proposed equipment.

(b) Daily and weekly rates for the use of the front end loader/backhoe with an operator.

3. Truckage services

Required for the transportation of earth material, including aggregates within a two mile radius of the Dumfries landfill. Truck/s needed are required to have a load carrying capacity of four (4) to six (6) cubic yards. The perspective supplier shall provide:

(a) Details of the make, model, age and capacity of the truck proposed.

(b) Rates for transportation of full load within half mile radius of the Dumfries Landfill and (c)

Rates for transportation of full load beyond half mile but no more than a two mile distance of

the Dumfries landfill.

Contractor obligations.

The Perspective contractor shall be responsible for:

- The proper working order including the upkeep, repair servicing and maintenance of all

equipment for the duration of the contract period including the provision of fuel, hydraulic

fluid, oils/ lubricants and all spear parts required for the specified works.

- Provision of the required health and safety protective gears/clothing for all staff employed

under the project and shall be responsible for any health and safety issues that may arise as they

will be required to work with waste/garbage.

The successful bidder shall enter into a formal contract with the Grenada Solid Waste Management

Authority following bid evaluations and negotiations for the procurement of the services and

equipment rental/lease.

Proposals must be submitted in writing clearly stating:

The Name of the company or owner of the equipment.

The submission date.
